Chapter Legacy Project Activities and Donations - 2020

For many years, the chapter has been engaged in activities to perpetuate and propagate azalea hybrids developed by chapter members and area hybridizers. These activities were expanded upon and documented in the Legacy Project which was formalized in the chapter in 2014. In 2017 the project was expanded society wide in the Azalea Society of America. What started out as four hybrid varieties in the project has expanded to 21. Chapters throughout the United States are currently involved in Legacy activities, including the development of Legacy Gardens.

The chapter has been involved and continues to be involved in Legacy Project activities, including providing McDonald and Glenn Dale azaleas to the Norfolk Botanical Garden and establishing a Klimavicz Legacy Garden at Meadowlark Gardens in Vienna, VA. Additionally, this year we assisted the Potomac Valley Chapter of the American Rhododendron Society by donating Marshy Point azaleas for their development of a Marshy Point Legacy Garden at Historic London Town and Gardens in Edgewater, MD.

The chapter has planted a Klimavicz Legacy Garden at Meadowlark Gardens and has plans for a future Bob Stewart Legacy Garden at the same site. The chapter entered into a Memorandum of Agreement with Meadowlark Gardens when developing the Klimavicz Legacy Garden where we agreed to provide a monthly level of maintenance for the garden. We are grateful to the chapter members who have participated in these workdays over the past year and we

We also contributed a large number of Holly Springs azaleas to Jenkins Arboretum in Devon, PA for the establishment of a Holly Springs Legacy Garden. Dave and Leslie Nanney made a delivery of Holly Springs azaleas to Jenkins in September and Rick and Susan Bauer made a follow up delivery in October. We will continue to work with Jenkins in the development and completion of their garden. In addition, we have also provided Holly Springs, Klimavicz and McDonald azaleas to Jenkins in 2018 and 2019.

Significant 2020 Items

The **Member-Only** sale this year was online for the first time, and was very successful. The **Fall Sale** was outside only, and was a scaled-down version with no auction. Plant sale revenue was approximately \$2,300 below budget, due to the COVID-19 restrictions.

The propagation expense was \$4,011.75 against a budget of \$4,800. Plants purchased from White's Nursery were \$1,008.00. There will be no plants purchased from White's in 2021, as he was unable to do cuttings for us in 2019. The suggested propagation expense budget for 2021 is therefore \$3,000 (supplies only).

The expenses for 2020 were significantly below budgeted, due to lack of plant sale expenses and significant reduction in printing expense for the Clipper. A member has volunteered to print the Clipper on his color laser printer, which produces a copy equivalent in quality to that produced by FedEx Office. The website domain was re-registered in 2020 for a cost of \$287.00. This expense is incurred every 3 years.
