Bob and I came home via the outskirts of Atlanta where we made our way to a fabulous nursery, Wilkerson Mill Hydrangeas and then later to Marion, NC where we visited and picked up amazing deciduous azaleas and an 'Augie Kerr' magnolia at the native plant nursery, Meadowbrook We-Du. Both ship great plants via the web so look them up and treat your garden to some of their fantastic offerings.

I encourage you all to attend the April 11 chapter meeting mentioned elsewhere mainly because it'll be our last meeting until the cutting exchange in July. At the meeting in April we will hold what we hope will be a twice yearly Plant Exchange at which interested (and who wouldn't be?) members will bring in any type of plant material to put in the "pool" and we'll all take turns choosing one plant at a time to correspond with the number of plants brought by each member. This will be entirely free and promises to be an exciting event, as everyone loves "free" plants. Orleans. While the unusually cold winter resulted in almost a total lack of blooming azaleas, the beautiful weather and the hospitality shown by the Louisiana Chapter ensured we all had a good time. I particularly enjoyed meeting and talking to chapter members from different parts of Virginia who normally can't attend our chapter meetings because of the distance involved. The Northern Virginia chapter had the largest representation of any chapter at the convention with 18 members and spouses in attendance. Details of the convention will be in a future Azalean and highlights will be presented at the chapter meeting on 11 April.

On 7 March we held our chapter meeting at Pohick Library in Burke. Bill Johnson, a horticulturist at Hillwood gave us a presentation, "Hillwood through the Seasons". This presentation, originally scheduled for our snow cancelled February meeting, showed us the beauty of Hillwood gardens through all four seasons.

During the business portion of the meeting, members were provided copies of the 2010 schedule and the budget, which was approved by the Executive Committee in January. Additionally members voted to provide to the ASA, \$2000 from the profits of our successful 2009 convention. We also voted to purchase tents and supporting equipment to be used in chapter fund raising and other activities. Finally, we approved \$1000 to purchase azaleas to sell at the Blandy plant sale in May.

Our next meeting will be held 11 April at the Pohick Library in Burke. At that meeting, one of the major agenda items will be to vote on by-laws for the chapter. While by-laws were created when the chapter was formed in 1980 and revised in later years, there is no known record of these modifications or of a current official set of bylaws. As a result, a new set was created based on a template provided by the ASA national organization and an early version of the chapter's bylaws. This set was approved by the Executive Committee on 24 January for presentation to the general membership for approval. A copy of the proposed by-laws was sent to those members receiving the monthly Azalea Update. A copy will also be posted on the Northern Virginia Chapter website. Any member who desires a copy of the proposed by-laws and can't

access them through the previously mentioned sources, may contact Rick Bauer for a hard copy.

Additionally we will be discussing final plans for chapter participation at Garden Week in Charlottesville 18-19 April and for the plant sale at Blandy Arboretum 7-9 May.

Finally, we're trying to institute/ reinstitute features of interest to our members. At the April 11th meeting we will be conducting a plant exchange. All members are asked to bring a plant or plants for exchange. The number of plants you bring will be the number of plants you can select from other members. We're hoping this will be a good opportunity for members to increase the number and variety of plants in their gardens.

I hope to see you on 11 April at Pohick Library.

March 7, 2010 Chapter Meeting, Lee McElvain, Acting Secretary

Members assembled at the Pohick Regional Library in Springfield, Virginia. The meeting was called to order by President Eve Harrison. She explained that the Treasurer's report would have to be deferred due to illness of the Treasurer, but advised those in attendance that the Chapter Treasury has a balance of approximately \$22,000 and advised that a formal report probably will be available at the next meeting

Rick Bauer, the Vice President, was then asked to discuss other Chapter business. He presented for discussion, a full year schedule of chapter activities and explained that some adjustments may be required as the year progresses. The schedule, he noted, was developed to coordinate Chapter activities with the activities of other groups and events in which our members share an interest. By "deconflicting" our meeting and events and posting them far in advance, it is hoped that the general membership will note the dates on their calendars and be available to participate in more of the events planned for this Chapter.

Following that discussion Rick moved to the subject of the New By- Laws recommended by the Chapter's Executive Committee. He explained that the proposed By- Laws would be made available by Internet and that he would mail hard copies to anyone requesting them. It was pointed out that a principal reason for considering the New By Laws is to create a known structure for the Chapter going forward, because no one seems to have a copy of the Old By- Laws, as amended,

previously. The provisions of the New By- Laws will be discussed and determined at the next regular meeting (which is scheduled for April 11, 2010),

Next, the Chapter's participation in the Virginia Garden Week at Charlottesville was discussed. Since this is an event to which the Chapter was specifically invited to participate, it was generally agreed that we should take part. No costs to the Chapter are expected for this event except that we must provide our supplies and equipment. Larry Martin, Chairman of the fundraising committee, said that several volunteers plan to participate, and any others wanting to do so should contact him. Some members have indicated a willingness to provide rooted cuttings to be sold or used for membership enhancement. Proceeds of sales would be deposited in our Chapter Treasury.

Rick introduced Bill Johnson, a veteran horticulturalist at The Hillwood Estate of Marjorie Merriweather Post in Washington, D.C. Mr Johnson's presentation of Hillwood made all of us want to visit its gardens during each season of the year. Although the gardens – like ours – suffered some damage from the heavy snows this year, it is expected that, come spring, they will be beautiful and ready for visitors.

Mr. Johnson walked us through the gardens using beautiful pictures by seasons. He showed us Hillwood in winter (you had to be there to appreciate the masterful photography) the snow swept scenes were like being in a wonderland. Then he moved into the spring plantings as they were starting to emerge into warmer weather and the landscapes as we would see them now. Every season – winter, spring, summer and fall – offered by his photography was beautiful as he described

what we were viewing and how they fit into a well designed landscape design that he had helped to develop over his 27 years there.

Every part of the Estate was described -- from the Japanese garden, to the pet cemetery, to the cutting garden, to the greenhouse - in a manner that we could feel like we were walking through the garden season by season – from the comfort of our seats, but they can be visited by anyone wishing to see it in real life with a leisurely walk at their own pace. Our thanks go out to Mr. Johnson for bringing this year-round experience.

Before concluding the meeting for the day, those present continued with the unfinished business. Several matters needed to be settled regarding the budget which had been recommended by the Executive Committee and circulated by Rick Bauer at the beginning of the meeting. Motions were made, seconded and approved either by voice vote or by hand (there was no apparent objection to any of them) as follows:

- A motion to approve an expenditure of \$1000 to purchase plants from White's Nursery for sale at the Blandy event.
- A motion to approve an expenditure of \$800 to purchase two tents and related supplies for the Chapter's use (a one time expense).
- A motion to authorize a donation of \$2000 to the Azalea Society of America.
- A motion to authorize the expenditure of \$150 for the use of space at Merrifield Gardens - Gainesville for the annual plant auction.
