Due to space constraints, the plants are tightly packed and present a blaze of color when in bloom. His garden also serves as a test bed, allowing him to evaluated plants. Due to space constraints, those plants which don't make the grade, are removed and replaced by other hybrids.

Presentations of the **Neckel**, **Bauer** and **Beck** gardens have been deferred to a future date.

We also had another of our popular plant exchanges. In addition to those plants brought by members, we had a large number of chapter propagated and raised azaleas to give away to members.

Significant 2023 Items

The most significant item from 2023 was the net proceeds from the convention of almost \$8,500. Due to the low registration numbers and high member expense, we anticipated incurring a loss from the convention.

Plant sale revenue was \$17,139.71, or 118% of the \$14,500 budget. The Member-Only sale this year was ad hoc, and was not very successful, yielding only \$1,417. Meadowlark plant sales were \$5,028, much better than expected. Meadowlark continues to be a highly successful venue.

The propagation expense was \$3,495.85 against a budget of \$3,000.

Suggested Club Donations, to be voted upon at the business meeting:

Current cash on hand is \$50,628.85. Current obligations are \$5,455. Our chapter is very healthy. The following are the recommended 2023 end of year donations:

Pecan Pie Cookies

2 eggs

1 c. packed brown sugar

1/2 c. melted margarine

- 1 c. flour
- 1 c. chopped pecans

Combine - all ingredients in bowl, mixing lightly

Pour - into greased muffin cups.

Bake - 350 degrees for 20 to 25 minutes for large 15 minutes for small.

Yield - 12 large or 36 small cookies.

*The above is the original recipe - I add a ¹/₂ to 1 tsp butter/vanilla flavoring or vanilla flavoring to give a richer taste.

*It also makes more than 36 cookies when I use my Pampered Chef cookie scoop (one tablespoon size) in a mini muffin pan. It is a #40 cookie scoop if yours is numbered.

*Depending on how your oven works the small cookies may only takes about 15 minutes to cook. *The second tray always seems to cook faster for me as well.*
